1. PAYMENTS BY DEBTOR -

- a. As of the date of this plan, the debtor has paid the trustee **\$4,098.00**.
- b. After the date of this plan, the debtor will pay the trustee **\$2,049.00** per **Month** for **58** months, beginning within 30 days after the filing of this plan for a total of **\$118,842.00**.
- c. The debtor will also pay the trustee: **\$0.00**

d. The debtor will pay the trustee a total of **\$122,940.00** [line 1(a) + line 1(b) + line 1(c)].

2. 


