### MODIFIED Chapter 13 Plan

#### 1. Payments by Debtor

- a. As of the date of this plan, the debtor has paid the Trustee **\$0.00**
- b. After the date of this plan, the debtor will pay the Trustee **\$1150.00** per month for **41** months, beginning within 30 days after the filing of this plan for a total of **\$47,150.00**
- c. The debtor will also pay the Trustee
- d. The debtor will pay the Trustee a total of **\$47,150.00** (line 1a + line 1b = line 1c)

#### 2. Payments by Trustee

The Trustee will make payments only to creditors for which proofs of claim have been filed, will make payments monthly as available, and collect the Trustee's percentage fee of 10% for a total of **\$4286.00** (line 1d \* .10) or such lesser percentage as may be fixed by the Attorney general. for purposes of this plan, month one (1) is the month following the month in which the debtor makes the debtor's first payment. Unless ordered otherwise, the Trustee will not make any payments until the plan is confirmed. Payments will accumulate and be paid following confirmation.

#### 3. Priority Claims

The Trustee shall pay in full all claims entitled to priority under Sec. 507, including the following. The amounts listed are estimates only. The Trustee will pay the amounts actually allowed.

### 9. Timely Filed Unsecured Creditors

The Trustee will pay holders of nonpriority unsecured claims for which Proofs-of-Claim forms were timely filed the balance of all payments received by the Trustee and not paid under paragraphs 2, 3, 5, 6, 7, and 8 their pro rata share of approximately \$13,878.00 (line 1d minus lines 2, 3e, 5d, 6d, 7h, and 8b).

- The debtor estimates that the total unsecured claims held by creditors listed in paragraph 7 are \$9200.00
- The debtor estimates that the debtor's total unsecured claims (excluding those in paragraphs 7 and 8 are \$21141.00
- The total estimated unsecured claims are \$30,341.00 (line 9a + line 9b)

### 10. Tardily filed Unsecured Creditors

All money paid by the Debtor to the Trustee under paragraph 1, but not distributed by the Trustee under paragraphs 2,3,5,6,7,8 and 9 shall be paid to holders of nonpriority claims for which Proof-of-Claim forms were tardily filed.

### 11. Other Provisions

The Trustee can disburse any funds not specifically designed for a creditor at his discretion. Upon completion of payment of the secured position of any claim, the property securing said claim shall vest in the debtor free and clear of any lien, claim or interest of the secured creditor.


