ORDER

This Chapter 13 case came before the Court on October 7, 2004, for Confirmation of the debtor's Chapter 13 Plan. Roylene A. 1. That the hearing on Confirmation and IRS's Objections and Motion is continued to November 4, 2004, at 10:30 a.m.

2. No later than two weeks from the date of this Order, the debtor shall file Federal Income Tax Returns for the years 1998, 1999, 2000, 2001, 2002 and 2003. The returns shall be forwarded for filing by mail or personal delivery to: Insolvency Unit of the Internal Revenue Service, STOP 5700, 316 North Robert St., St. Paul, MN 55101. At the reconvened confirmation hearing, the debtor shall be prepared to prove full compliance with this obligation.

If necessary, no later than two weeks from the date of this Order, the debtor shall file a motion for modification, with a modified plan appended, and shall serve that motion in conformity with Loc. R. Bankr. P. (D.Minn.) 3015-2(a). Counsel for the debtor shall schedule the hearing on the motion for the date specified in paragraph 1 of this Order.

4. Any failure by the debtor to fully and timely comply with the terms of this Order shall constitute cause for dismissal of this case pursuant to 11 U.S.C. § 1307(c)(1).
