2. AGENDA: The attorneys who plan to try the case shall be present and shall be prepared to discuss:

- d. Possible settlement.


3. PREPARATION: The attorneys shall discuss settlement possibilities prior to the scheduling conference.

4. Upon settlement, each party has an independent obligation and shall notify the calendar clerk, within 24 hours after a settlement agreement has been reached. Unless the Court orders otherwise, the settlement documents shall be filed within ten (10) days after oral notice of the settlement.

5. The parties must appear personally or through their attorneys. Failure to appear may result in the imposition of sanctions under Bankruptcy Rule 7016 and Fed. R. Civ. P. 16(f).

Fed.R.Civ.P.26(a)(1), (a)(2), (a)(3) and (f) do not apply in this proceeding.


