STEERING COMMITTEE'S SECOND OMNIBUS OBJECTION TO CLAIMS

COMES NOW Enovation Graphic Systems, Inc. ("Enovation") by and through its undersigned counsel, and files this Response to the Steering Committee's Second Omnibus Objection to Claims:

**PROCEDURAL POSTURE**

Enovation properly filed proof of claim number 65 for \$18,590.67 (hereafter "Claim 65").

The Steering Committee's Second Omnibus Objection to Claims objects to Enovation's claim as being filed in an amount exceeding the amount listed on debtor's Schedules. The Steering Committee's Second Omnibus Objection to Claims seeks to reduce the claim filed from \$18,590.67 to \$8,536.73.

**ARGUMENT**

Enovation's claim filed in the amount of \$18,590.67 is valid and should be allowed in said amount. Attached to Enovation's claim is supporting documentation including copies of

Statements dated March 1, 2002, on two accounts, account numbers 270705004 and 270705000 in the amounts of \$10,777.62 and \$7,634.48, respectively, which total the amount of \$18,412.10. Attached to the Proof of Claim is a calculation of the balance due as of the date of the filing of debtor's Bankruptcy Petition. Said balance is \$18,412.10, including interest.


The Steering Committee's Second Omnibus Objection to Claims provides no detailed calculation or documentation for the amount for which it seeks reduction of the claim of Enovation. It does not address the documentation of the claim attached to Enovation's Proof of Claim and has shown no basis for reduction of the claim other than the fact that debtor's Schedules list the claim in the lower amount.

### **CONCLUSION**

For all the reasons stated above the Steering Committee's Objection to the Claim of Enovation should be dismissed and Enovation's Claim Number 65 should be allowed as filed.


