TO: Debtor(s), Debtor(s) Attorney, all parties in interest under Local Rule 9013-3, and the United States Trustee.

1. Jasmine Z. Keller, (Trustee), moves the Court for the relief requested below and gives notice of hearing.

2. The Court will hold a hearing on this motion at 10:30 a.m., or as soon thereafter as counsel may be heard, on **September 11, 2003**, in U.S. Bankruptcy Court, Courtroom 228A, Second Floor, United States Courthouse, 316 North Robert Street, St Paul, Minnesota.

3. Any response to this motion must be filed and delivered not later than 10:00 a.m. on September 8, 2003, which is three days before the time set for the hearing (excluding Saturdays, Sundays, and holidays), or filed and served by mail not later than September 2, 2003, which is seven days before the time set for the hearing (excluding Saturdays, Sundays, and holidays). ***Unless a response opposing the motion is timely filed, the court may grant the motion without a hearing.***

4. The Court has jurisdiction of this motion pursuant to 28 U.S.C. §§157 and 1334, Bankruptcy Rule 5005 and Local Rule 1070-1. This proceeding is a core proceeding. This motion arises under 11 U.S.C. §1307 and Bankruptcy Rule 1017. This motion is filed under Bankruptcy Rule 9013 and Local Rule 9013-1 *et seq.* The petition commencing this Chapter 13 case was filed on 7/10/03. The case is now pending in this Court.

5. If testimony is necessary as to any facts relevant to this motion, Lora Low, Chapter 13 Office, 12 South 6th Street, Suite 310, Minneapolis, Minnesota, will testify on behalf of the Trustee.

6. The Trustee requests that this case be dismissed or converted to a Chapter 7 case, and such other relief as the Court deems just, for the following reason(s):

A. Debtor(s) have failed to appear at §341(a) meeting of creditors and has not been examined.

B. Debtor(s) have failed to make the initial payment proposed by the plan within 30 days after the plan was filed, (11 U.S.C. §1326(a)(1)), and subsequent plan payments that may come due by the date of the hearing on this motion.

C. The plan term has expired. The amount needed to complete the plan is \$.

D. The Trustee has received a non-sufficient funds check. **All future payments need to be made by money order or cashier's check if this motion is denied or withdrawn.**

() E. Confirmation of the Debtor(s)' plan has been denied.

**The August, 2003 payment is not included in the listed default amount.**

Any payment less than the amount required to bring the plan current will not prevent dismissal of this case. If the default, including the payment due for August, is brought current by the hearing date, the Trustee will strike the motion.

**WHEREFORE** the Trustee requests an order granting the relief prayed for herein.
