Request for Summary Judgment in the matter of Claim Number 48

I am Gunther Karger residing at 14950 S.W. 86th Avenue, Village of Palmetto Bay, Florida 33158 and Certify that I am Claimant Number 48 in the matter before this Court. I continue to respectfully ask the Court to validate Claim Number 48 and reject Debtor's objection thereto.

It is my belief that sufficient information has been presented to the Court, inclusive with this brief, to render a decision based on such facts and representations. It is not my intention to take up the Court's time further with this matter and it is my understanding that Mr. Ronald Thomas, CEO of Astrocom and Debtor concurs with this.

I also introduce the attached statement already submitted to the Court on August 23, 2004 as part of the "Ballot to creditors" by Mr. S. Albert Diez Hanser relevant to Claim Number 48. In his statement, which is attached to this brief, Mr. Hanser states **"I know his(Gunther Karger) claim to be valid and should be included"**. For the Court's reference, Mr. Hanser came to Astrocom about 1991 as its CEO and principal investor, served as CEO and Chairman of the Board until He brought in Mr. Thomas and remains presently as "secured Creditor". Mr. Hanser is founder and CEO of Sanibel and Captiva Trust Company, a trust bank in Florida. Mr. Hanser and I have known each other for about 15 years and is closely familiar with my role in securing financing and marketing opportunities for Astrocom as presented in my original Claim and supporting subsequent briefs.

Now therefore, I respectfully beg the Court to consider these matters brought before it in connection with claim Number 48 and issue a "**Summary Judgment**" to include Claim Number 48 as part of the Disclosure Statement and Plan submitted by Debtor and approved by the Court.
