Motion for Judicial Ruling on Claim Number 48

I am Gunther Karger residing at 14950 S.W. 86th Avenue, Village of Palmetto Bay, Florida 33158 and Certify that I am Claimant Number 48 in the matter before this Court.

I respectfully **move** that the Court to rule on the matter of Claim Number 48 based on the information thus far and inclusive herein already submitted. I further **move** that the Court cancel the September 21 hearing scheduled solely to hear this single matter on the basis that it wastes the Court's time and debtor's very limited resources.

Prior information submitted to the Court by myself supplemented by Mr. Albert Hanser clearly demonstrates that Gunther Karger over the past several years materially contributed to the raising of approximately \$500,000 in private placement capital and provided the Company(Debtor) with significant new business opportunities inclusive of specific projects, setting up of meetings and introducing Astrocom to potential buyers of Astrocom's products. Claim Number 48 is the sole claim contested by Astrocom and this objection is unjustified. Moreover, the Debtor thus far has spent potentially more funds out of extremely limited cash reserves to contest this Claim than the Claim was ever nor could ever be worth. This is an improper use of funds for a corporation strapped for operating funds which should be used solely to restart the company's business.

Therefore, I respectfully beg the Court to take all these matters into consideration and issue a ruling based on information thus far inclusive herein submitted to avoid further wasting the Court's time for a matter that should never have been brought to Court in the first place. I respectfully beg the Court to reject the debtor's objection to Claim 48.
