Counsel shall be available to receive the conference call from the Court, and shall be ready to discuss the issues of fact and law to be presented at the evidentiary hearing.

4. *Evidentiary Hearing.* On *September 29, 2004, at 9:30 a.m.*, the motion for dismissal will come on before the Court for an evidentiary hearing. Both parties shall pre-mark all exhibits, the United States Trustee by number and the Debtor by letter.
