NOTICE OF MOTION AND MOTION
FOR AN ORDER DIRECTING DEBTOR
TO SURRENDER PROPERTY

TO: The debtor and other entities specified in Local Rule 9013-3.

1. Michael J. Iannacone moves the Court for the relief requested below and gives notice of hearing.
2. The Court will hold a hearing on this motion at 11:00 a.m. on November 4, 2004 in Courtroom 228A, United States Courthouse, 316 North Robert Street, St. Paul, Minnesota or as soon thereafter as counsel may be heard.
3. Any response to this motion must be filed and delivered not later than October 28, 2004, which is seven (7) days before the time set for the hearing (including Saturdays, Sundays, and holidays), or filed and served by mail not later than October 25, 2004, which is ten (10) days before the time set for the hearing (including Saturdays, Sundays and holidays). **UNLESS A RESPONSE OPPOSING THE MOTION IS TIMELY FILED, THE COURT MAY GRANT THE MOTION WITHOUT A HEARING.**
4. The Court has jurisdiction over this motion pursuant to 28 U.S.C. §§ 157 and 1334, Bankruptcy Rule 5005 and Local Rule 1070-1. This is a core proceeding.
5. The petition commencing this Chapter 7 case was filed on March 25, 2004. The case is now pending in this Court.
6. This motion arises under 11 U.S.C. § 521(4) and Bankruptcy Rule 4002.

7. Movant is the trustee of the bankruptcy estate of the debtor. The debtor has failed to surrender and continues to withhold the following estate property from the trustee:

Bank deposits in the amount of \$527.60 and non-exempt wages in the amount of \$597.85 for a total of \$1,125.45.

8. Debtor is required to surrender and deliver to the trustee all estate property, 11 U.S.C. § 521(4).

WHEREFORE, Movant requests an Order of the Court directing debtor to surrender forthwith all of the property of the estate described above to the trustee at the address indicated for the trustee and \$500.00 in legal fees and cost and disbursement incurred in bringing on this motion and for such other and further relief as the Court deems just and equitable in the proceeding.
