In a joint case,
debtor means debtors in this plan.

1. PAYMENTS BY DEBTOR -

- a. As of the date of this plan, the debtor has paid the trustee **\$0.00**.
- b. After the date of this plan, the debtor will pay the trustee **\$150.00** per **Month** for **36** months, beginning within 30 days after the filing of this plan for a total of **\$5,400.00**.
- c. The debtor will also pay the trustee: **\$0.00**
- d. The debtor will pay the trustee a total of **\$0.00** [line 1(a) + line 1(b) + line 1(c)].

2. PAYMENTS BY TRUSTEE - The trustee will make payments only to creditors for which proofs of claim have been filed, make payments monthly as available, and collect the trustee's percentage fee of 10.00% for a total of **\$540.00** [line 1(d) x .10] or such lesser percentage as may be fixed by the Attorney General. For purposes of this plan, month one (1) is the month following the month in which the debtor makes the debtor's first payment. Unless ordered otherwise, the trustee will not make any payments until the plan is confirmed. Payments will accumulate and be paid following confirmation.

3. PRIORITY CLAIMS - The trustee shall pay in full all claims entitled to priority under § 507, including the following. The amounts listed are estimates only. The trustee will pay the amounts actually allowed.

9. **TIMELY FILED UNSECURED CREDITORS** - The trustee will pay holders of nonpriority unsecured claims for which proofs of claim were timely filed the balance of all payments received by the trustee and not paid under ¶ 2, 3, 5, 6, 7 and 8 their pro rata share of approximately **\$1,242.58** [line 1(d) minus lines 2, 3(e), 5(d), 6(d), 7(d) and 8(b)].

- a. The debtor estimates that the total unsecured claims held by creditors listed in ¶ 7 are **\$2,000.00**
- b. The debtor estimates that the debtor's total unsecured claims (excluding those in ¶ 7 and ¶ 8) are **\$ 24,126.78**
- c. Total estimated unsecured claims are **\$26,126.78** [line 9(a) + line 9(b)].

10. **TARDILY-FILED UNSECURED CREDITORS** - All money paid by the debtor to the trustee under ¶ 1, but not distributed by the trustee under ¶ 2, 3, 5, 6, 7, 8 or 9 shall be paid to holders of nonpriority unsecured claims for which proofs of claim were tardily filed.

11. **OTHER PROVISIONS -**

- A. DEBTORS WILL CONTRIBUTE ALL PROJECTED MONTHLY DISPOSABLE INCOME TO THE CHAPTER 13 TRUSTEE FOR DISTRIBUTION TO THEIR CREDITORS THROUGH THEIR CHAPTER 13 PLAN FOR THE FIRST 36 MONTHS OF THE PLAN.
- B. DEBTORS WILL CONTRIBUTE ALL PROJECTED YEARLY TAX REFUNDS TO THE CHAPTER 13 TRUSTEE FOR DISTRIBUTION TO THEIR CREDITORS THROUGH THEIR CHAPTER 13 PLAN FOR THE FIRST 36 MONTHS OF THE PLAN.
- C. DEBTORS WILL MAKE THEIR REGULAR MONTHLY MORTGAGE PAYMENTS TO WASHINGTON MUTUAL HOME MORTGAGE DIRECTLY.
- D. DEBTORS WILL MAKE THEIR REGULAR MONTHLY PAYMENTS DIRECTLY TO FIRST STATE BANK REGARDING THEIR 1999 FORD EXPEDITION SUV AND THEIR 2002 DODGE RAM 1500 QUAD CAB.
- E. UNTIMELY FILED CLAIMS WILL RECEIVE NO DISTRIBUTION WHATSOEVER.
