MINN.) 3015-2(b) and 3019-2, no later than *Friday, August 6, 2004*. Counsel for the Debtor shall schedule the hearing on the motion for August 26, 2004, at 10:30 a.m., or
 - b. convert this case to one under Chapter 7 by filing the verified conversion, exhibits, attachments, schedules, statements, and lists contemplated by Loc. R. BANKR. P. (D. MINN.) 1019-1(a), no later than *Wednesday, August 25, 2004*, or
 - c. file a cure proposal no later than *Wednesday, August 25, 2004*.

2. The hearing on the Standing Trustee's motion is continued to August 26, 2004, at 10:30 a.m. Any failure by the Debtor to fully comply with either a., b., or c. of Term 1 of this order will constitute cause for dismissal of this case.
