

Agreed Continuance of Chapter 13 Case

A text-only agreed continuance may be filed by the debtor, debtor’s attorney, trustee, creditor or creditor’s attorney after all interested parties have confirmed their agreement to the continuance. The request must be filed no later than 3:00 p.m. on Monday prior to the scheduled Chapter 13 hearing calendar.

The following agreed continuance events are available:

Agreed Continuance of Preconfirmation Chapter 13 Confirmation Hearing
 Agreed Continuance of Chapter 13 Motion to Dismiss
 Agreed Continuance of Motion to Modify Confirmed Chapter 13 Plan

Upon docketing, the applicable hearing will be deemed continued to the selected Chapter 13 calendar. Clerk’s Office staff will update the public-facing judicial calendar accordingly.

A separate agreed continuance filing is required for each hearing item being continued unless the matters are heard as part of the same confirmation hearing event. For example:

- If a case has both a preconfirmation confirmation hearing and a Motion to Dismiss scheduled on the same calendar, two separate agreed continuance entries must be filed.
- If a case has a confirmation hearing and an objection to confirmation scheduled in connection with that confirmation hearing, only one continuance entry is required.

Filing a Modified Chapter 13 Plan and Notice of Confirmation Hearing event automatically continues the preconfirmation confirmation hearing. A separate Agreed Continuance of Preconfirmation Chapter 13 Confirmation Hearing is not required in that circumstance. However, if a Motion to Dismiss remains pending on the same calendar, a separate Agreed Continuance of Chapter 13 Motion to Dismiss must still be filed.




Failure to file an agreed continuance for each applicable hearing item may result in orders being entered on matters not properly continued. If that occurs, parties may be required to file a motion to vacate the resulting order.
