Notice to Clerk Regarding Personally Identifiable Information Found

When reviewing filings submitted by *other* parties, individuals may occasionally identify personally identifiable information (PII) within a document that does not comply with the redaction requirements set forth in Fed. R. Bankr. P. 9037(a). To notify the court of this issue, users should follow the steps outlined below.

The resulting text-only docket entry will be restricted from public access upon filing and will be not viewable by the public. Court staff will review the entry and take appropriate next steps, which may include restricting the identified document(s) from public access and notifying the original filer so they must proceed with filing a motion to redact.

When filing a notice regarding PII, users must select the appropriate CM/ECF event based on where the information appears:

- If the PII is found within a document filed on the case docket, use the event "Notice to Clerk Regarding Personally Identifiable Information Found in Filed Document".
- If the PII is found within a proof of claim on the claims register, use the event "Notice to Clerk Regarding Personally Identifiable Information Found on Claims Register".
