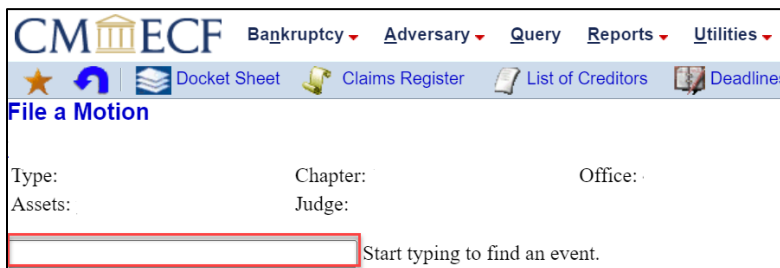
UNITED STATES BANKRUPTCY COURT FOR THE DISTRICT OF MINNESOTA
