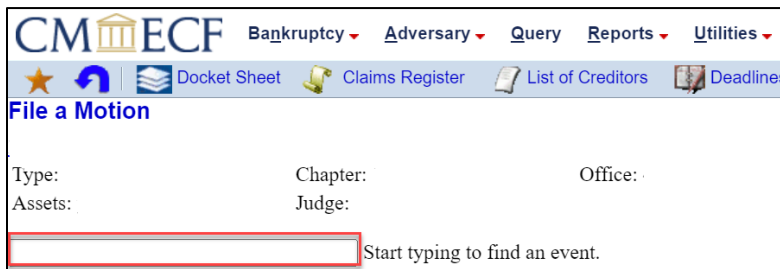

Always refer to the text of the applicable statute or rule for further guidance. For purposes of this “Cheat Sheet,” the citations to the Federal Rules of Bankruptcy Procedure, the Federal Rules of Civil Procedure, and the Local Rules have been shortened to “FRBP,” “FRCP,” and “LR,” respectively. Likewise, “§” refers to a section in Title 11 of the United States Code unless otherwise noted. Please use the proper citations in any documents filed with the court.
