

Option 2:


The Corporate Ownership Statement can be docketed as an attachment within an existing event:

1. When docketing a motion, response or objection, there is an option to add attachments to your primary document.



Underneath the file upload box, you will see additional next with two radio buttons. After attaching your primary document, select the "Yes" radio button. Select Next to go to the next screen.

2. On the next screen, upload your attachment file. Then select the category type as "Corporate Ownership Statement" – and "Add to List" before selecting "Next"



3. If you are filing a response or an objection, relate your filing to the appropriate event and review docket text before docketing.
