PUBLIC NOTICE

PROPOSED AMENDMENTS TO LOCAL RULES

The United States Bankruptcy Court for the District of Minnesota is issuing for public comment proposed amendments to several local rules in the 1000 and 9000 series. The proposed amendments include two new Local Rules: Local Rule 9013-4. Corporate Ownership Statements and Local Rule 9036-1. Notice and Service on Non-Filing Users and Trustees. The Court also seeks to abrogate three forms.

The purpose of these amendments is to conform the Local Rules and Local Forms with the Federal Rules of Bankruptcy Procedure and current practice. These proposed amendments are the first set of proposed amendments that are part of a larger project to substantively review all Local Rules.
