

Request for Continuance in Chapter 13 Case

A text-only request for continuance may be submitted to the court by a debtor, debtor’s attorney, trustee or creditor’s attorney after all interested parties have agreed to making the request. The request must be submitted by 3:00 pm the day before the affected Chapter 13 hearing date. See Local Rule 5071-1. The court will review the request and, if approved, continue the case to the next Chapter 13 hearing date for the assigned judge.

If the request to continue a hearing relates to a motion – select the motion.

If multiple hearings for the same case and date are being continued, select all applicable items.
