

# Trustee Recommendation for Confirmation

The Trustee Recommendation for confirmation is a text only event filed by the Chapter 13 Trustee after the objection deadline has expired and no later than 3:00 p.m. on the Monday preceding the scheduled confirmation hearing date. There are two events available for confirmation.

**Trustee Recommendation for Chapter 13 Plan Confirmation**– for preconfirmation cases scheduled for an initial confirmation hearing.

**Trustee Recommendation for Postconfirmation Chapter 13 Plan Modification**– for hearings on Motion to Modify a Chapter 13 Plan.

Upon docketing, the event will place the case into the confirmation queue for automated processing and update the public chapter 13 calendar. After the Chapter 13 hearing calendar has concluded, the court’s automated docketing process will enter the confirmation order in cases that remain eligible for confirmation.

If circumstances change after the recommendation is filed. The Trustee’s Office may utilize the associated withdrawal event to remove the case from the confirmation queue. Once withdrawn, the Trustee’s Office must determine the appropriate next action.

Filing a withdrawal does not automatically continue or remove any scheduled hearing from the calendar.
